COMPLIANCE – You and any drivers of the vehicle described on the rental agreement are responsible for the following:

1. **UNAUTHORIZED DRIVERS** – This vehicle cannot be driven by any person other than the Renter(s) listed on the agreement.
2. **IN CASE OF ACCIDENT** – You may be held responsible for all damages if you fail to provide a police report within 15 days. THIS COVERAGE IS IN NO WAY LIABILITY COVERAGE OF ANY KIND. THIS IS ONLY FOR PHYSICAL DAMAGE DONE TO THE GOLF CART IN EXCESS OF THE SECURITY DEPOSIT ON FILE.
3. **D.W.I.** – I do hereby certify that if I or anyone else driving this vehicle is cited or convicted of driving under the influence of drugs or drunken driving, that I assume all responsibility and this waiver is null and void. If this occurs, I am responsible for all damages.
4. **ALL PARKING TICKETS/TRAFFIC VIOLATIONS** – Are the full responsibility of the renter(s).
5. **VEHICLE INSPECTION** – Before and after renting vehicle, both Agent and Renter shall inspect vehicle for physical damage and note any damage on the back of this rental agreement.

I AGREE TO ADHERE TO THE WARNINGS, TERMS AND CONDITIONS OF THIS ADDITIONAL COVERAGE AGREEMENT AND TO RETURN THE VEHICLE TO LESSOR ON OR BEFORE RENTAL EXPIRATION DATE AND AT PLACE SPECIFIED.
